**RELEASE OF SECURITY INTEREST IN CERTAIN PATENTS,
PATENT APPLICATIONS, TRADEMARK APPLICATIONS, TRADEMARK
REGISTRATIONS AND COPYRIGHTS**

KNOW ALL MEN BY THESE PRESENTS, that Bank of Montreal, a chartered bank of Canada, acting as administrative agent (“**Agent**”), was granted security interests by Laborie Medical Technologies Corp., a Delaware corporation (“**Debtor**”), pursuant to (i) that certain Patent Collateral Agreement dated as of July 11, 2012, recorded with the United States Patent and Trademark Office on July 11, 2012 at Reel/Frame 028544/0653 (the “**Patent Collateral Agreement**”), (ii) that certain Trademark Collateral Agreement dated as of July 11, 2012, recorded with the United States Patent and Trademark Office on July 11, 2012 at Reel/Frame 004819/0260 (the “**Trademark Collateral Agreement**”), and (iii) that certain Copyright Collateral Agreement dated as of July 11, 2012 recorded with the United Copyright Office on July 16, 2012 at Volume/Document 3618/524 (the “**Copyright Collateral Agreement**,” together with the Patent Collateral Agreement and Trademark Collateral Agreement, the “**IP Security Agreements**”), to the (a) patents and applications therefor, (b) trademark applications and registrations therefor, and (c) copyright registrations and applications therefor, identified in Exhibit A, Exhibit B and Exhibit C, respectively, annexed hereto and made a part hereof (together with (w) all of the inventions described and claimed in each such patents and patent applications and any and all reissues, continuations, continuations-in-part or extensions thereof, (x) all of the goodwill of the business connected with the use of, and symbolized by, each such trademark registration and trademark application, (y) all of the works of authorship described and claimed in such copyright registrations and copyright applications, and any and all renewals, derivative works, enhancements, modifications, new releases and other revisions thereof, and (z) all proceeds of the foregoing, collectively, the “**IP Collateral**”).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Agent hereby (i) terminates each of the IP Security Agreements, and (ii) unconditionally and expressly terminates, cancels, and releases any and all security interests or liens it has in, upon, or against the IP Collateral. If and to the extent any right, title, or interest to any such IP Collateral was previously assigned, sold, granted, conveyed, or transferred by Debtor to Agent, Agent hereby irrevocably assigns, sells, grants, conveys, and transfers to Debtor such right, title, and interest in and to such IP Collateral (together with (a) all products and proceeds of the foregoing (including any claim against third parties for past, present or future infringement or dilution of any such IP Collateral or injury to the goodwill associated therewith, and (b) all goodwill of the business connected with the use of, and symbolized by, such IP Collateral).


