TRADEMARK ASSIGNMENT AGREEMENT

WHEREAS, Assignor is the proprietor of the mark TRIP.COM, Registration Number(s) 2696186 (hereinafter referred to as "Mark").

WHEREAS, Assignor has agreed to assign the Mark to Assignee, and Assignee wishes to acquire all of the Assignor's rights in and to the Mark, along with the goodwill associated therewith, and hereby accepts the assignment.

NOW THEREFORE, in consideration of ten dollars (U.S. \$10.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby assigns, transfers and conveys to Assignee, its successors and assigns, its entire right, title and interest in and to the Mark including the right to sue in respect of all infringements of the Mark, which may have occurred before the effective date of this Agreement, and the right to all remedies including damages or an account of the profits and conversion damages in respect of such infringements, together with the goodwill of the business in which the Mark is used, or with that part of the goodwill of the business connected with the use of and symbolized by the Mark, and the entire business of the Applicant/Assignor or the portion of the business to which the Mark pertains where necessary.
