

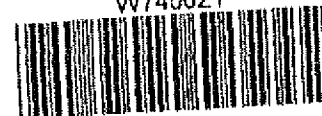
1. The name of the corporation is PACKAGING TECHNOLOGIES, INC.
