TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT (this "Assignment") is executed and delivered as of this 3rd day of July, 2010 (the "Effective Date") to Cooper Brands, Inc., a Delaware corporation (the "Buyer"), by Easco Hand Tools, Inc., a Delaware corporation ("Easco"), Armstrong Tools, LLC, a Delaware limited liability company ("Armstrong"), Delta Consolidated Industries, LLC, an Arkansas limited liability company ("Delta"), H-K Connecticut Holding Company, LLC, a Delaware limited liability company ("H-K") and Jacobs Chuck Manufacturing Company, LLC, a Delaware limited liability company ("Jacobs Chuck", and together with Easco, Armstrong, Delta and H-K, "Sellers"), and each of Hand Tool Design Corporation, a Delaware corporation ("HTDC"), Industrial Fasteners, Inc., a Delaware corporation ("IFI") and Power Tool Holders Incorporated, a Delaware corporation ("PTHI", and together with HTDC and IFI, the "Affiliates," and collectively with Sellers, the "Asset Transferors"). Capitalized terms used in this Assignment and not otherwise defined in this Assignment shall have the respective meanings ascribed to such terms in the Intellectual Property Rights Transfer Agreement, of even date herewith, by and among Sellers and the Buyer (the "IP Transfer Agreement").

WHEREAS, this Assignment is being executed and delivered pursuant to the IP Transfer Agreement;

WHEREAS, the Asset Transferors are the owners of the trademark registrations and applications therefor identified on Schedule A hereto and the trademarks which are the subject thereof, including the goodwill of the business connected with the use of, and symbolized by, said marks (collectively, the "Acquired Trademarks"); and

WHEREAS, pursuant to the IP Transfer Agreement, each Seller agreed (and agreed to cause its Affiliates) to sell, assign, transfer, convey and deliver to the Buyer, and the Buyer agreed to purchase and acquire from Sellers, free and clear of all Liens, other than Permitted Liens, all of the Asset Transferors' respective right, title and interest in and to the Acquired Trademarks at the Effective Date.

NOW, THEREFORE, in consideration of the representations, warranties, covenants and agreements contained in the IP Transfer Agreement and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Asset Transferors each hereby agree as follows:

1. The Asset Transferors do hereby assign to the Buyer all of Asset Transferors' respective right, title and interest in and to the Acquired Trademarks, including the goodwill of the business connected with the use of and symbolized by each mark included in the Acquired Trademarks, together with the right to recover for past infringement of each such mark, and the right to seek registration of each such mark anywhere in the United States or elsewhere in the world.

2. This Assignment is being executed and delivered by the Asset Transferors in accordance with the IP Transfer Agreement and is expressly made subject to those liabilities, obligations and commitments which the Buyer has expressly assumed and agreed to perform, pay and discharge pursuant to the IP Transfer Agreement executed and delivered by the Buyer as of the date hereof.


