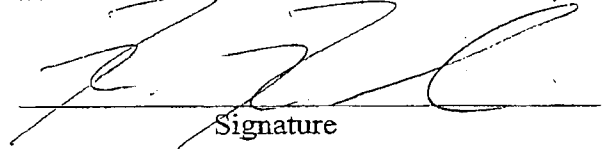

The street address of the registered office is 117 River Run Dr, Ketchum, ID 83340 and the name of the registered agent at such address is R. Randolph Ashton.

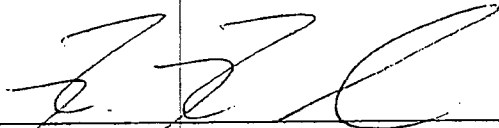
