Pursuant to the provisions of the Washington Business Corporation Act governing the merger of a domestic wholly-owned subsidiary business corporation into its foreign parent business corporation, the foreign parent business corporation hereinafter named does hereby submit the following articles of merger:

1. The name of the subsidiary corporation, which is a business corporation organized under the laws of the State of Washington, is Decide, Inc. ("Decide").
2. The name of the parent corporation, which is a business corporation organized under the laws of the State of Delaware, is eBay Inc. ("eBay").
3. The number of outstanding shares of Decide is 100, all of which are of one class, and all of which are owned by eBay.
4. The Plan of Merger merging Decide with and into eBay as approved by the Board of Directors of eBay is attached hereto as Exhibit A.
5. eBay in its capacity as the holder of all of the outstanding shares of Decide waived the mailing of a copy of the Plan of Merger to eBay otherwise provided for under the provisions of Section 23B.11.040 of the Washington Business Corporation Act.
6. The laws of the jurisdiction of organization of eBay permit a merger of a wholly-owned subsidiary business corporation of another jurisdiction into a parent business corporation of the jurisdiction of organization of eBay, and the merger of Decide into eBay is in compliance with the laws of the jurisdiction of organization of eBay.
7. Shareholder approval was not required.

8. The effective time of the merger herein provided for in the State of Washington shall be 11:59 pm, Pacific Time, on October 1, 2013.

PLAN OF MERGER OF

DECIDE, INC., a Washington corporation

WITH AND INTO

EBAY INC., a Delaware corporation

1. eBay Inc. ("eBay"), which is a business corporation of the State of Delaware and is the owner of all of the outstanding shares of Decide, Inc. ("Decide"), which is a business corporation of the State of Washington, hereby merges Decide into eBay pursuant to the provisions of the Washington Business Corporation Act and pursuant to the provisions of the Delaware General Corporation Law.

2. The separate existence of Decide shall cease as of 11:59 p.m., Pacific Time, on October 1, 2013 (the "Effective Time") pursuant to the provisions of the Washington Business Corporation Act, and eBay shall continue its existence as the surviving corporation pursuant to the provisions of the Delaware General Corporation Law.

3. The articles of incorporation of eBay are not amended in any respect by this Plan of Merger.

4. The issued shares of Decide shall not be converted or exchanged in any manner, but each said share which is issued immediately prior to the Effective Time shall, at the Effective Time, be surrendered and extinguished.

5. All outstanding stock of eBay shall remain outstanding and shall not be changed or otherwise affected.

6. No shares of eBay and no shares, securities, or obligations convertible into such shares are to be issued or delivered under this Plan of Merger.

7. The Board of Directors and the proper officers of eBay are hereby authorized, empowered, and directed to do any and all acts and things, and to make, execute, deliver, file, and/or record any and all instruments, papers, and documents which shall be or become necessary, proper, or convenient to carry out or put into effect any of the provisions of this Plan of Merger or of the merger herein provided for.
