ADDITIONAL ADDENDUM TO THE SHARE AND ASSET PURCHASE AGREEMENT

DATED 10 APRIL 2012

- SUPPLEMENTAL TRADEMARK ASSIGNMENT AGREEMENT

This SUPPLEMENTAL TRADEMARK ASSIGNMENT AGREEMENT (the "Supplement") is made and entered into by and between:

**Trelleborg AB (publ)**, a company incorporated in Sweden, registration number 556006-3421, P.O. Box 153, SE-231 22 Trelleborg, Sweden ("TAB")

and

**Trelleborg Industri AB**, a company incorporated in Sweden, registration number 556129-7267, Johan Kocksgatan 10, SE-231 45 Trelleborg, Sweden ("**Trelleborg Industri**") on one hand;

and

**Ansell Limited**, an Australian company, (ABN 89 004 085 330), having its principal place of business at Level 3, 678 Victoria Street, Richmond, Victoria 3121, Australia ("**the Buyer**") on the other hand.







Each referred to individually as a "Party" and together as the "Parties". TAB and Trelleborg Industri are together referred to as the "Sellers".

1. Background

1.1 The Sellers are the registered owners of the trademarks as set forth in Exhibit 1A (the "Trademarks"). On 10 April 2012 TAB, Trelleborg Industries Inc, Trelleborg Singapore PFE Ltd, Trelleborg Industrial Products Norway AS on one hand and Ansell Healthcare B.V. on the other hand entered into a Share and Asset Purchase Agreement for the sale and purchase of Trelleborg Protective Products Business (the "SAPA"). The Parties are in agreement that the Trademarks, including any and all rights, title and interest in and to the Trademarks, are included in the sale and purchase and that the Buyer shall be the owner of and hold the beneficial interest in the Trademarks.

1.2 On 2 May 2012 the parties signed an addendum to the SAPA – a Trademark Assignment Agreement (the "Agreement").

1.3 The Parties hereby confirm that the Trademarks shall be considered part of the assignment and transfer under the Agreement, and the Trademarks in Exhibit 1A thus included in and governed by the Agreement. The terms and conditions as defined in the Agreement shall have the same signification for this Supplement.
