**RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY ("Release"), dated as of December 2, 2013, is made by Computershare Trust Company of Canada, as collateral agent for the parties from time to time, as secured creditors (collectively, the "Secured Creditors") party to the Collateral Agency Agreement referred to below (in such capacity, the "Collateral Agent"), for and on behalf of itself and the Secured Creditors, in favor of Pharmco Products, Inc. (including as successor by merger to AAPER Alcohol and Chemical Company) and GreenField Ethanol Inc. (now, GreenField Specialty Alcohols Inc.) (collectively, the "Pledgors"). Except as otherwise provided herein, capitalized terms used herein without definition shall have the meanings given to them in the Collateral Agency Agreement referred to below.

**WHEREAS**, reference is made to the intercreditor and collateral agency agreement, dated as of December 15, 2011 (as amended, modified or supplemented from time to time, the "Collateral Agency Agreement"), among GreenField Specialty Alcohols Inc. ("Borrower"), its subsidiaries and affiliates parties thereto, the Secured Creditors from time to time parties thereto, and the Collateral Agent;

**WHEREAS**, in connection with the Collateral Agency Agreement, and pursuant to a security agreement dated December 15, 2011 by and among AAPER Alcohol and Chemical Company and Computershare Trust Company of Canada, as collateral agent, a security agreement dated December 15, 2011 by and among Pharmco Products, Inc. and Computershare Trust Company of Canada, as collateral agent, and a trust deed dated September 27, 1996 between Commercial Alcohols Inc. (being the former name of GreenField Ethanol Inc.) and Montreal Trust Company of Canada, as collateral agent (including as assigned to Computershare Trust Company of Canada) (as amended, amended and restated, supplemented or otherwise modified from time to time, collectively, the "Security Agreements") and pursuant to a patent security agreement dated December 15, 2011 by and among AAPER Alcohol and Chemical Company and Computershare Trust Company of Canada, as collateral agent, a trademark security agreement dated December 15, 2011 by and among AAPER Alcohol and Chemical Company and Computershare Trust Company of Canada, as collateral agent, a trademark security agreement dated December 15, 2011 by and among Pharmco Products, Inc. and Computershare Trust Company of Canada, as collateral agent, and a confirmation of security interest in intellectual property dated December 15, 2011 by and among GreenField Ethanol Inc. and Computershare Trust Company of Canada, as collateral agent (collectively, the "Intellectual Property Security Agreements"), the Pledgors granted to the Collateral Agent a security interest in certain Collateral, including but not limited to, the patents and patent applications set forth in Schedule A hereto (the "Patents") and the trademark and service mark registrations and applications set forth in Schedule B hereto (the "Trademarks"), which the Intellectual Property Security Agreements were recorded in the United States Patent and Trademark Office at the Reel/Frame Numbers indicated in the Schedules hereto.

**WHEREAS**, the Pledgors have requested that the Collateral Agent release its security interest in the Collateral, including the Patents and Trademarks; and

**WHEREAS**, the Collateral Agent, for and on behalf of itself and the Secured Creditors, has agreed to terminate and release the entirety of its security interest in and to the Pledgors' Collateral, including the Patents and Trademarks.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Collateral Agent, for and on behalf of itself and the Secured Creditors, hereby releases, terminates and discharges, without representation, recourse or warranty whatsoever, any and all of its security interest in the Collateral, including the Patents and Trademarks.


