**TERMINATION OF SECURITY INTEREST IN TRADEMARKS**

WHEREAS, EIKO, Ltd., a Kansas corporation was the owner of record of the trademarks and applications listed on **Exhibit A**, attached hereto, now issued or pending in the United States Patent and Trademark Office (the "**Trademarks**");

2. Authorizes and requests the Commissioner of Patents and Trademarks of the United States of America to note and record the existence of the release hereby given.
