**ARTICLES OF AMENDMENT TO
ARTICLES OF INCORPORATION
OF
ADMIRALTY ISLAND FISHERIES, INC.**

Pursuant to RCW 23B.10.060 of the Washington Business Corporation Act, the undersigned corporation hereby submits the following amendment to the corporation's Articles of Incorporation.

1. The name of the corporation is Admiralty Island Fisheries, Inc.
2. Article 1 of the corporation's Articles of Incorporation is amended to read in its entirety as follows:

ARTICLE 1

NAME

The name of the corporation is Aqua Star (USA), Corp.

3. This amendment does not provide for an exchange, reclassification, or cancellation of issued shares.
4. The date of the adoption of this amendment was November 1, 2006.
5. The amendment was adopted by the Board of Directors. Shareholder action was not required pursuant to RCW 23B.10.020.
6. This amendment will be effective upon filing with the Secretary of State.
