**RELEASE AND REASSIGNMENT OF

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Bank hereby terminates the Agreement and releases and reassigns to Grantor, without representation or warranty, all of Bank's right, title and interest in and to the Marks and the goodwill associated therewith.
