## **RELEASE OF SECURITY INTEREST IN TRADEMARKS**


THIS RELEASE is made as of this 26th day of November, 2013, by WELLS FARGO CAPITAL FINANCE, LLC, as Agent, a Delaware limited liability Companies, ("Wells"), in favor of VOXEL DOT NET, INC., a Delaware corporation and UBERSMITH, INC., a Delaware corporation (the "Companies"). Wells consents and agrees to execute and deliver, at the request and cost of Companies, such further instruments, documents, releases and release forms as Companies may reasonably request to more effectively, release, terminate and extinguish any such liens and security interests upon the Trademark Collateral.

This Release shall be binding upon Wells' legal representatives, assigns and successors.
