NOTICE OF RELEASE OF SECURITY INTEREST IN U.S. TRADEMARKS

This NOTICE OF RELEASE OF SECURITY INTEREST IN U.S. TRADEMARKS (as amended, restated, supplemented or otherwise modified, this “Notice of Release”), effective as of December 2, 2013, is made by WELLS FARGO BANK, NATIONAL ASSOCIATION, as Administrative Agent (the “Administrative Agent”).

WHEREAS, ON ASSIGNMENT, INC., a Delaware corporation (“Grantor”) having a principal place of business at 26745 Malibu Hills Road, Calabasas, California 91301 and the Administrative Agent, are party to that certain (i) Notice of Grant of Security Interest in Trademarks, dated as of May 16, 2013 (the “2013 Trademark Notice”) and (ii) Notice of Grant of Security Interest in Trademarks, dated as of May 15, 2012 (the “2012 Trademark Notice,” and together with the 2013 Trademark Notice, the “Trademark Notices”), in each case, whereby Grantor granted to the Administrative Agent a continuing security interest in the trademarks and trademark applications identified on Schedule A thereto, including, without limitation, the following Trademarks (the “Specified Trademark Collateral”):

WHEREAS, the 2012 Trademark Notice was recorded in the records of the U.S. Patent and Trademark Office on May 17, 2012 at Reel No. 4782, Frame 0784.

WHEREAS, the Administrative Agent has agreed to release its security interest in, and discharge fully its lien on, the Specified Trademark Collateral in accordance with the terms of the Trademark Notices, and as herein provided;

shall remain in full force and effect with respect to all trademarks, trademark applications and all related proceeds, products, rents, profits and claims with respect thereto, other than the Specified Trademark Collateral.

The invalidity or unenforceability of any provision of this Notice of Release shall not affect the validity or enforceability of any other provision of this Notice of Release, which shall remain in full force and effect.

This Notice of Release and all of the provisions hereof shall be binding on and inure to the benefit of the parties hereto and their respective successors and assigns.
