TRADEMARK ASSIGNMENT

This Trademark Assignment ("Assignment") is made by and between Advanced Polymer Technology, Inc., a Michigan corporation, having a place of business at 2817 McCracken Avenue, Muskegon, Michigan, (hereinafter "Assignor"), and Franklin Electric Co., Inc., an Indiana corporation, having a place of business at 9255 Coverdale Road, Fort Wayne, Indiana 46809 (hereinafter "Assignee").

NOW, THEREFORE, Assignor, for and in exchange of valuable consideration, the receipt and sufficiency of which is hereby acknowledged, does hereby assign, transfer, grant and convey to Assignee, free and clear of all pledges, security interests, liens, charges, encumbrances, equities, claims, options or limitation of every kind, all of Assignor's worldwide right, title and interest in, to and under the Marks, together with the goodwill of the business associated therewith and which is symbolized thereby, all rights to sue for infringement thereof, whether arising on, prior to or subsequent to the date of this Assignment, and any and all applications, registrations, renewals and extensions thereof that may hereafter be secured under the laws now or hereafter in effect in the United States and in any other jurisdiction, the same to be held and enjoyed by Assignee, its successors and assigns from and after the date hereof as fully and entirely as the same would have been held and enjoyed by Assignor had this Assignment not been made. Assignor shall execute, acknowledge and deliver to Assignee, at Assignee's request, any and all further documents, papers, affidavits, statements and other instruments, in the format required by Assignee, to confirm Assignee's ownership of all rights pursuant to this Assignment, and shall take all steps to enable and ensure that the goodwill of the business associated with and symbolized by the Marks is transferred under this Agreement. This Assignment shall be binding upon the successors and assigns of the Assignor and inure to the benefit of the successors and assigns of Assignee.

Except to the extent that federal law preempts state law with respect to the matters covered hereby, this Assignment shall be governed by and construed in accordance with the laws of the State of Indiana without giving effect to the principles of conflicts of laws thereof.
