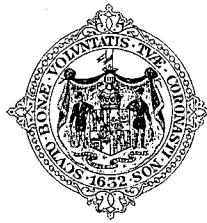

The undersigned, on behalf of the corporation set forth below, pursuant to Subtitle 9 of the Maryland General Corporation Law, hereby executes the following articles of conversion ("Article of Conversion") and sets forth:

ONE

- A. The name of the corporation immediately prior to the Effective Time (as defined below) of these articles of entity conversion is Kimmich Software Systems, Inc. (the "Corporation"). The Corporation's original Articles of Incorporation were filed with the Maryland State Department of Assessments and Taxation on September 15, 1994.
- B. These Articles of Conversion shall be effective immediately upon acceptance hereof by the Maryland State Department of Assessments and Taxation (the "Effective Time").
- C. At the Effective Time, the Corporation shall convert to Kimmich Software Systems, LLC, a limited liability company organized under the laws of the State of Maryland (the "LLC").
- D. At the Effective Time and in connection with such conversion, the shares of the Corporation shall be converted into a percentage of membership interests of the LLC as set forth below:






