In accordance with the requirements of the Indiana Business Corporation Law, the undersigned corporation surviving a merger pursuant to Indiana Code 23-1-40-1 et seq (the "Merger"), sets forth the following facts:

ARTICLE I
Surviving Corporation

The name of the corporation surviving the Merger is PIPELINE ACQUISITION CORP. (the "Surviving Corporation"). The name of the Surviving Corporation will be changed as a result of the Merger to MILLER PIPELINE CORPORATION. The Surviving Corporation is an Indiana corporation which was incorporated on July 19, 1995.

ARTICLE II
Merging Corporation

The name of the corporation merging with and into the Surviving Corporation is MILLER PIPELINE CORPORATION (the "Merging Corporation"). The Merging Corporation is an Ohio corporation which was incorporated on June 24, 1957 and qualified to do business in Indiana on May 22, 1962.

ARTICLE III
Plan of Merger

The Plan and Agreement of Merger for the Merger of the Merging Corporation with and into the Surviving Corporation containing the information required by Indiana Code 23-1-40-1(b) (the "Plan of Merger"), is attached hereto as Exhibit A and made a part hereof.

ARTICLE IV
Effective Time

The Merger shall become effective at 5:00 p.m., Indianapolis time, on August 21, 1995.

ARTICLE V
Manner of Approval and Vote

Section 1. Action by Surviving Corporation. By written consent of the sole director dated as of July 21, 1995, the Board of Directors of the Surviving Corporation approved the Plan of Merger and recommended it for approval by the Merging Corporation's shareholders. By written consent of the sole shareholder dated as of July 21, 1995, the holder of all 100 of the Surviving Corporation's issued and outstanding shares of common stock, without par value, approved the Plan of Merger, and such affirmative vote was sufficient to approve the Plan of Merger.

Section 2. Action by Merging Corporation. At a meeting held on July 21, 1995, the Board of Directors of the Merging Corporation adopted the Plan of Merger and recommended it for approval by the Merging Corporation's shareholders. All 233,300 of the Merging Corporation's issued and outstanding shares of common stock, no par value, were entitled to vote on the Plan of Merger, and, at a meeting held on August 17, 1995, the holders of 233,300 shares of the common stock of the Merging Corporation approved the Plan of Merger, and such affirmative vote was sufficient to approve the Plan of Merger.

IN WITNESS WHEREOF, the Surviving Corporation has caused these Articles of Merger to be signed by its duly authorized officer on this 22nd day of August, 1995.
