NUNC PRO TUNC ASSIGNMENT

WHEREAS, MORTGAGE CADENCE, LLC, a limited liability company organized under the laws of Delaware, having its registered address at 999 18th Street, Suite 2300, Denver, Colorado 80202 (hereinafter "Assignor") is the owner of the trademarks listed on the attached Schedule A, and the goodwill symbolized thereby ("the Trademarks"); and

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor has assigned and hereby sells, assigns, transfers and sets over to Assignee, nunc pro tunc as of July 31, 2013, the entire right, title, interest in and to the Trademarks and the goodwill of the business connected with the Trademarks, the same to be held and enjoyed by Assignee, its successors, assigns and other legal representatives.

Assignor further assigns to Assignee all right to sue for and receive all damages accruing from past infringements of the Trademarks assigned.

This Assignment shall be binding upon the parties, their successors and/or assigns and all others acting by, through, with or under their direction, and all those in privity therewith.
