GRANT OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY COLLATERAL

This GRANT OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL (this "Grant"), dated as of October 23, 2013 is made by THE REHAB DOCUMENTATION COMPANY, INC., having an address of 12 Cadillac Drive, Suite 300, Brentwood, TN 37027 ("Borrower") to CAPSTAR BANK, having an address of 201 4TH Avenue North, Suite 950, Nashville, TN 37219 (the "Secured Party") under the Credit Agreement referred to below.





Borrower further agrees, at Secured Party's expense, to cooperate with the Secured Party and to provide Secured Party with any additional information or authorization if it is required or desirable to effect the recording or perfection of the Secured Party's security interest in the Collateral described herein.
