RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE dated as of December 6, 2013 (this "Release") is made by General Electric Capital Corporation, acting in its capacity as administrative agent and collateral agent (the "Administrative Agent") for each of the Lenders (as defined in the Trademark Security Agreement referenced below) under that certain Trademark Security Agreement, dated as of May 20, 2011, and recorded in the records of the United States Patent and Trademark Office, at Reel 004547/Frame 0386, between SUNCREST HEALTHCARE, INC., (the "Grantor"), and the Agent;


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent does hereby release its security interest in the
