## RELEASE OF TRADEMARKS

THIS RELEASE OF TRADEMARKS is dated as of November 13, 2013 (“Release”) by General Electric Capital Corporation, as Administrative Agent, in its capacity as Agent for itself and the Lenders (“Agent”).

WHEREAS, Agent, International Automotive Technicians’ Network, Inc., a California corporation, and Identifix, Inc., a Minnesota corporation (individually, a “Grantor”, and, collectively, the “Grantors”), entered into that certain Trademark Security Agreement, dated as of July 25, 2013 (the “Trademark Security Agreement”);

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby agrees as follows:


