ASSIGNMENT

WHEREAS, Assignee desires to acquire all of Assignor's right, title, and interest to the Mark;

NOW, THEREFORE, in consideration of the foregoing promises, covenants and agreements contained herein, the Parties agree to be bound as follows:


1. Assignor assigns to Assignee all of Assignor's right, title, and interest in and to the Mark, including, but not limited to, the following:
 - 1.1 All common law rights;
 - 1.2 The goodwill resulting from any use of the Mark; and
 - 1.3 The right to sue third parties for, and recover damages from, past and future infringement of the Mark.
 - 1.4 Any and all rights, title and interest Assignee has, holds, and/or can transfer or grant.
2. The right, title, and interest conveyed in this Assignment is to be held and enjoyed by Assignee and Assignee's successors and assigns as fully and exclusively as it would have been held and enjoyed by Assignor had this Assignment not been made.
3. Assignor hereby authorizes the Commissioner of Patents and Trademarks of the United States and/or the Director of the US Patent and Trademark Office, and any official of any other country empowered to issue trademark registrations, to record this Assignment, to issue or transfer the Mark to the Assignee as owner of all right, title and interest therein, or otherwise as the Assignee may direct in accordance with the terms of this Agreement.
4. This Assignment is made without any representations or warranties regarding whatever interests may be assigned, if any, or with respect to any other matter, and all rights taken hereunder are granted on a quitclaim basis.

6. Assignor further agrees to (a) cooperate with Assignee in the protection of the Mark; (b) execute, verify, acknowledge, and deliver all such further papers; and (c) perform such other acts as Assignee lawfully may request to obtain or maintain the Mark.


