RELEASE OF GRANT OF A SECURITY INTEREST – TRADEMARKS

December 5, 2013

WHEREAS, pursuant (a) that certain Trademark Security Agreement dated as of August 15, 2008 by and between US GREENFIBER LLC, a Delaware corporation (“Releasee”) and WELLS FARGO BANK, NATIONAL ASSOCIATION, a national banking association (as successor-in-interest to WACHOVIA BANK, NATIONAL ASSOCIATION, “Releasor”), recorded on October 9, 2008 at Reel 3867, Frame 0579 in the United States Patent and Trademark Office (as amended, restated, supplemented or otherwise modified, “Trademark Security Agreement No. 1”), (b) that certain Trademark Security Agreement dated as of August 15, 2008 by and between Releasee and Releasor, recorded on October 9, 2008 at Reel 3867, Frame 0905 in the United States Patent and Trademark Office (as amended, restated, supplemented or otherwise modified, “Trademark Security Agreement No. 2”) and (c) that certain Modified and Restated Trademark Security Agreement dated as of December 1, 2011 by and between Releasee and Releasor, recorded on January 12, 2012 at Reel 4697, Frame 0217 in the United States Patent and Trademark Office (as amended, restated, supplemented or otherwise modified, “Trademark Security Agreement No. 3” and together with Trademark Security Agreement No. 1 and Trademark Security Agreement No. 2, the “Trademark Security Agreements”), Releasee granted to Releasor a continuing security interest in all right, title and interest of the Releasee in, to and under the trademarks owned by Releasee, including the trademarks listed on Schedule A attached hereto, and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof (the “Collateral”); and

WHEREAS, Releasee has requested and Releasor has agreed to provide a document suitable for recording in the United States Patent and Trademark Office for purposes of evidencing the release, relinquishment, discharge and termination of Releasor’s security interest in the Collateral.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, Releasor hereby agrees as follows:

1. Defined Terms. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreements.
2. Release of Security Interest. Releasor hereby, without any representation and warranty, releases, relinquishes and discharges its security interest in the Collateral.
