TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of November 21, 2013 by GENERAL ELECTRIC CAPITAL CORPORATION, as administrative agent (in such capacity, “**Agent**”) for certain financial institutions.

WITNESSETH:


