### **TRADEMARK ASSIGNMENT**

THIS TRADEMARK ASSIGNMENT (this "Trademark Assignment"), dated as of December 6, 2013, is made and entered into by and between LNT Acquisition, LLC, a Delaware limited liability company ("Assignor"), and LNT Brands LLC, a Delaware limited liability company ("Assignee").

WHEREAS, Assignor and Assignee have entered into that certain Asset Purchase Agreement, dated as of December 6, 2013 (the "Asset Purchase Agreement"), pursuant to which the Assignor has agreed to sell to Assignee all of Assignor's right, title and interest in and to, among other things, the Acquired Intellectual Property, including the Designated Trademarks (as such terms are defined in the Asset Purchase Agreement); and

WHEREAS, Assignor and Assignee desire to execute this Trademark Assignment for purposes of recording the assignment of the Designated Trademarks and filing this Trademark Assignment with the United States Patent and Trademark Office and/or any other applicable intellectual property offices and/or similar agencies outside of the United States, as may be necessary to effectuate the assignment of the Designated Trademarks.

NOW, THEREFORE, in consideration of the premises and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto hereby agree as follows:

1. Assignment. Assignor hereby sells, assigns, conveys, transfers and delivers to Assignee all of Assignor's right, title and interest throughout the world in and to (a) the Acquired Intellectual Property, including the Designated Trademarks (together with all goodwill associated therewith) and the corresponding registrations and applications listed on Attachment 1 attached hereto and (b) (i) all rights pertaining to the Acquired Intellectual Property, including those arising under international treaties and convention rights; (ii) the right and power to assert, defend and recover title to the Acquired Intellectual Property; (iii) all rights to assert, defend, sue, and recover damages for any past, present and future infringement, misuse, misappropriation, impairment, unauthorized use or other violation of any rights in or to the Acquired Intellectual Property; (iv) all proceeds, income, royalties, damages and payments now and/or hereafter due and payable under and/or in respect of the Acquired Intellectual Property; and (v) all administrative rights arising from the Acquired Intellectual Property, including the right to prosecute applications and oppose, interfere with or challenge the applications of others, the rights to obtain renewals, continuations, divisions, and extensions of legal protection pertaining to the Acquired Intellectual Property.

2. Terms of the Asset Purchase Agreement. This Trademark Assignment is subject in all respects to the terms and provisions of the Asset Purchase Agreement, including but not limited to Assignor's representations, warranties and covenants relating to the Acquired Intellectual Property. Assignor acknowledges and agrees that the representations, warranties and covenants contained in the Asset Purchase Agreement shall not be superseded hereby but shall remain in full force and effect to the full extent provided therein. In the event of any conflict or inconsistency between the terms of the Asset Purchase Agreement and the terms hereof, the terms of the Asset Purchase Agreement shall govern.


3. Miscellaneous. The provisions of Article VI of the Purchase Agreement shall apply to this Agreement, *mutatis mutandis*.
