Assignor hereby assigns, sells and transfers unto said Assignee all right, title and interest in and to the said Marks (including any common law rights that may exist and are associated therewith), together with (a) the registration of and registration application for said Marks, (b) the goodwill of the business symbolized by and associated with said Marks and the registrations thereof, the same to be held and enjoyed by said Assignee, its successors, permitted assigns or legal representatives, and (c) together with income, royalties, damages or payments due on or after the date hereof, including, without limitation, all claims for damages or payments by reason of infringement or unauthorized use of the Marks, along with the right to sue for past infringements and collect same for Assignee's sole use and enjoyment.




