**TERMINATION AND RELEASE OF LIEN SECURITY INTEREST**  
**IN TRADEMARK RIGHTS – US TRADEMARKS**

TERMINATION AND RELEASE OF SECURITY INTEREST AGREEMENT,  
dated June 27, 2013, (this “Release”) by **ORIENTAL BANK**, a Puerto Rico banking  
corporation (“Oriental”).

**WITNESSETH**

**WHEREAS**, Procesadora Campofresco, Inc. (“Campofresco”) granted security interests  
(the “Trademark Security Interests”) in the federal trademark registrations set forth in the  
attached Schedule A (the “Trademark Collateral”) to Banco Bilbao Vizcaya Puerto Rico  
(“BBVA”);

**WHEREAS**, liens evidencing the Trademark Security Interests (the “Trademark Liens”) were recorded in the records of the United States Patent and Trademark Office;

**WHEREAS**, the rights of BBVA to the Trademark Security Interests and the Trademark Liens were assigned to Oriental as successor of BBVA by merger;

**WHEREAS**, Oriental desires to release the Trademark Security Interests and terminate the Trademark Liens;

**NOW, THEREFORE**, Oriental hereby declares as follows:

**Section 1. Release.** Oriental hereby unconditionally and irrevocably releases and terminates the Trademark Security Interests and Trademark Liens.

**Section 2. Governing Law.** This Release shall be governed by and construed in accordance with the laws of the Commonwealth of Puerto Rico.
