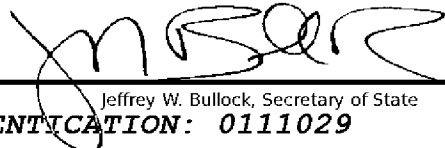

Pursuant to Title 8, Section 252 of the Delaware General Corporation Law, the undersigned corporation executed the following Certificate of Merger:

FIRST: The name of the surviving corporation is SmartBear Software Inc., a Delaware corporation, and the name of the corporation being merged into this surviving corporation is Boca Internet Technologies, Inc., a Florida corporation.

SECOND: The Agreement of Merger has been approved, adopted, certified, executed and acknowledged by each of the constituent corporations pursuant to Title 8 Section 252 of the General Corporation Law of the State of Delaware.

THIRD: The name of the surviving corporation is SmartBear Software Inc., a Delaware corporation.

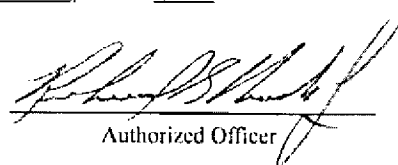
SIXTH: The merger is to become effective on December 31, 2012.
