
RELEASE OF SECURITY INTEREST

TRADEMARK

Santander Bank, as successor in interest to Sovereign Bank (the "Lender"), for good and valuable consideration, hereby releases and discharges its security interest in the trademark, more particularly described on Schedule A annexed hereto and made a part hereof (the "Trademark"), and the goodwill associated therewith (the "Security Interest").
