FULL RELEASE AND RECONVEYANCE OF SECURITY INTERESTS

Reference is hereby made to (i) that certain Amended and Restated Credit Agreement dated as of July 22, 2010 (as amended by the First Amendment to Credit Agreement dated as of February 17, 2012, the Second Amendment to Credit Agreement dated as of July 31, 2012, and the Third Amendment to Credit Agreement dated as of December 3, 2013, and as further amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), by and among the **CHECKPOINT SYSTEMS, INC.**, a Pennsylvania corporation (the "Company"), **CHECKPOINT MANUFACTURING JAPAN CO. LTD.**, a company formed under the laws of Japan, **CP INTERNATIONAL SYSTEMS C.V.**, a limited partnership (*commanditaire vennootschap*) formed under Dutch law, those Domestic Subsidiaries of the Company from time to time party thereto (the "Domestic Subsidiary Guarantors"), those Foreign Subsidiaries of the Company from time to time party thereto (together with the Foreign Borrowers, the "Foreign Guarantors"), the certain banks and financial institutions from time to time party thereto (the "Lenders") and **WELLS FARGO BANK, NATIONAL ASSOCIATION**, as administrative agent for the lenders ("Administrative Agent"), (ii) that certain Note Purchase and Private Shelf Agreement dated as of July 22, 2010 (as amended by the First Amendment to Note Purchase Agreement and Private Shelf Agreement dated as of February 17, 2012, the Second Amendment to Note Purchase and Private Shelf Agreement dated as of July 31, 2012, and the Third Amendment to Note Purchase and Private Shelf Agreement dated as of December 3, 2013, and as further amended, restated, supplemented or otherwise modified from time to time, the "Note Purchase Agreement"), by and among the Company, each Subsidiary of the Company from time to time party thereto and each of the Noteholders from time to time party thereto (the "Noteholders") and (iii) that certain Collateral Agency and Intercreditor Agreement dated as of July 22, 2010 (as amended by the First Amendment to Collateral Agency and Intercreditor Agreement dated as of July 31, 2012, and the Second Amendment to Collateral Agency and Intercreditor Agreement dated as of December 3, 2013, and as further amended, restated, supplemented or otherwise modified from time to time, the "Intercreditor Agreement"), by and among the Administrative Agent, **PRUDENTIAL INVESTMENT MANAGEMENT, INC.** ("Prudential") and **WELLS FARGO BANK, NATIONAL ASSOCIATION**, as collateral agent for Prudential, the Noteholders and the Bank Secured Parties (as defined in the Intercreditor Agreement) (the "Collateral Agent"). Unless otherwise defined herein, terms defined in the Credit Agreement and used herein shall have the meanings given to them in the Credit Agreement.

This Full Release and Reconveyance of Security Interests is granted by the Collateral Agent, having a place of business at 1525 West W.T. Harris Boulevard, Mail Code NC0680, Charlotte, NC 28262, in favor of the Company, having a place of business at 101 Wolf Drive, Thorofare, New Jersey 08086.

WHEREAS, pursuant to (i) that certain Security Agreement dated July 31, 2012, by and among the Company, the Domestic Guarantors and the Collateral Agent and (ii) that certain Notice of Grant of Security Interest in Trademarks recorded with the United States Patent and Trademark Office ("USPTO") on August 2, 2012, at Reel 4834, Frame No. 0346, the Company granted to the Collateral Agent, for the ratable benefit of the Lenders, a continuing security

interest (the "Security Interest") in, and a right to set off against, any and all right, title and interest of the Company in and to the Trademarks and Trademark Licenses (each as defined in the Security Agreement) listed on the attached Schedule A (hereinafter collectively referred to as the "Trademark Collateral");

NOW, THEREFORE, in consideration of the fulfillment of certain covenants made by the Company, and having full authority to do so, the Collateral Agent hereby forever and fully releases and discharges its Security Interest in the Trademark Collateral and reconveys to the Company, to the extent of its interest therein, the Trademark Collateral, without recourse.

This Full Release and Reconveyance of Security Interests may be filed with the USPTO.

This Full Release and Reconveyance of Security Interests shall be governed by and construed in accordance with the laws of the State of New York without regard to any principles of conflicts of law that would cause the laws of another jurisdiction to apply.

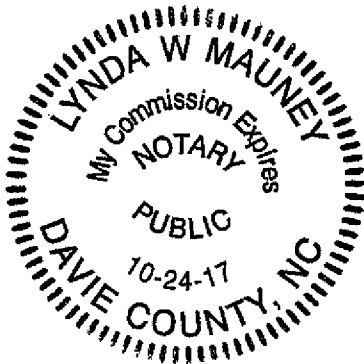
