TRADEMARK ASSIGNMENT

This Trademark Assignment (the "Assignment") is made and entered into as of December 6, 2013, by Clark & Wamberg, LLC, a Delaware limited liability company ("Assignor"), in favor of Aon Consulting, Inc., a New Jersey corporation ("Assignee").

WHEREAS, Assignor owns all the right, title and interest in and to the trademark for which it has obtained registration in the U.S. Patent and Trademark Office identified on **Schedule I** (collectively, the "Trademark and Registration"), together with the goodwill of the business associated therewith;

WHEREAS, Assignor and Assignee are parties to the Asset Purchase Agreement, dated as of December 2, 2013 (the "Purchase Agreement"); and

WHEREAS, pursuant to the Purchase Agreement, Assignor has agreed to sell, assign, transfer, convey and deliver to Assignee all right, title and interest in and to the Trademark and Registration, and the goodwill associated therewith.


NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, Assignor conveys and assigns to Assignee, free and clear of all Liens other than Permitted Liens (as defined in the Purchase Agreement), all of its right, title and interest in and to the Trademark and Registration, in the United States and all jurisdictions outside the United States (including all common law rights in and to such Trademark and Registration, the right to apply for trademark registrations within or outside the United States based in whole or in part upon the Trademark and Registration, and any priority right that may arise from use of the Trademark and Registration), and all goodwill of the business represented and symbolized thereby, with all rights to sue and recover damages and/or profits for past infringements, the same to be held and enjoyed by Assignee, its successors and assigns as fully and entirely as said interest could have been held and enjoyed by Assignor had this conveyance and assignment not been made.

Assignor further agrees, without further consideration, to promptly cause to be performed such lawful acts and to be executed such further assignments and other lawful documents as Assignee may reasonably request to effectuate fully this Assignment and to permit Assignee to be duly recorded in all applicable jurisdictions as the registered owner and proprietor of the rights hereby conveyed.
