RELEASE OF GRANT OF A SECURITY INTEREST - TRADEMARKS

WHEREAS, pursuant to that certain Grant of Security Interest - Trademarks, dated March 23, 2010 (the "Trademark Security Agreement"), recorded in the United States Patent and Trademark Office at Reel 4176, Frame 0697 on March 30, 2010, Hostway Services, Inc., a Delaware corporation (the "Releasee"), granted to Fortress Credit Corp., a Delaware corporation (the "Releasor"), as Collateral Agent for itself and certain lenders, a continuing security interest in all right, title and interest of the Releasee in, to and under the Trademarks, including the Trademarks listed on Schedule A attached hereto, and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof (the "Collateral"); and

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, Releasor hereby agrees as follows:

1. Defined Terms. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.
2. Release of Security Interest. Releasor hereby, without any representation and warranty, releases, relinquishes and discharges its security interest in the Collateral.
