This Assignment is effective this the 26th day of March, 2012.





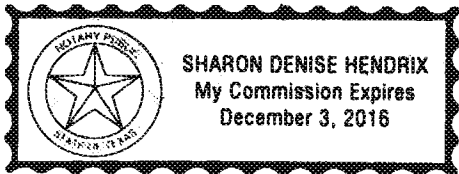
