## CONFIRMATORY RELEASE OF JUDGMENT LIEN

This **CONFIRMATORY RELEASE OF JUDGMENT LIEN** (the "Confirmatory Release"), effective as of December 13, 2013 is made by and between **MCENANY ROOFING, INC.** (hereinafter "McEnany Roofing"), a Florida corporation, a party to the McEnany Judgment (defined below) and the Settlement Agreement and Release (defined below), with **CRANE ACQUISITION, LLC**, a Wisconsin limited liability company organized under the laws of Wisconsin ("Crane Acquisition"), a party to the Settlement Agreement and Release, with respect to all assets identified or referred to in Exhibit A to the Settlement Agreement and Release (hereinafter the "Purchased Assets"), including but not limited to, the trademarks of Crane Acquisition and registrations therefore, listed in Schedule A to this Confirmatory Release (hereinafter, the "Crane Acquisition Marks").

WHEREAS on February 19, 2009, McEnany Roofing obtained a Final Judgment (hereafter the "McEnany Judgment") against Crane Cams, Inc. The McEnany Judgment attached to certain assets owned by Crane Cams, Inc. via judgment liens filed with the Secretary of State of the State of Florida, the Clerk of Court of Polk County, Florida, and the Clerk of Court of Volusia County, Florida and the recording of the McEnany Judgment with the U.S. Patent and Trademark Office with respect to the Crane Acquisition Marks as set forth below:

- Trademark Lien, dated as of February 19, 2009, in favor of McEnany Roofing, which was recorded with the U.S. Patent and Trademark Office on April 14, 2009, at Reel/Frame No. 003970-0414

(the "McNenany Liens");

WHEREAS, on May 6, 2009, Crane Cams, Inc. consented to the foreclosure by Wachovia Bank, National Association ("Wachovia"), its secured lender, on all of its personal property and assets;

WHEREAS, on May 8, 2009, Crane Acquisition purchased a portion of such (the "Purchased Assets"), including but not limited to, the Crane Acquisition Marks, from Wachovia Bank;

WHEREAS, Crane Acquisition requested that McEnany Roofing release and discharge the McEnany Liens with respect to the Purchased Assets;

WHEREAS, pursuant to the Settlement Agreement and Release effective December 13, 2013, McEnany Roofing released and discharged the McEnany Liens with respect to the Purchased Assets;

NOW, THEREFORE, McEnany Roofing hereby releases, agrees to and confirms the release and full discharge, effective December 13, 2013, of the McEnany Liens as it relates to the Purchased Assets vis-à-vis Crane Cams, Inc. and Crane Acquisition, and any other right, interest or right of control McEnany Roofing may have in relation to the Purchased Assets. To the extent that McEnany Roofing has any remaining right or interest in the Purchased Assets, McEnany Roofing hereby assigns and agrees to assign such remaining right or interest to Crane Acquisition.

McEnany Roofing will cooperate with Crane Acquisition, at the sole cost and expense of Crane Acquisition, including performance of any actions, and the execution and delivery of any documents necessary or appropriate to give effect to the intent and terms of this Confirmatory Release and allow Crane Acquisition to effectively record it with any appropriate government offices.

IN WITNESS WHEREOF, McEnany Roofing has caused this Confirmatory Release to be duly executed by its officer thereunto duly authorized, as of the 13<sup>th</sup> day of December, 2013.
