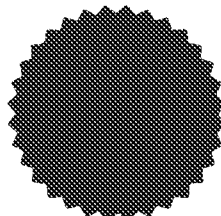

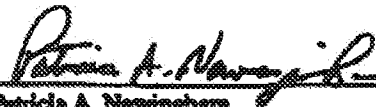
FIRST. The name of the corporation is REC Investments, Inc. The name under which the corporation was originally incorporated is Respirolics Investment Company.
