INTELLECTUAL PROPERTY ASSIGNMENT

This INTELLECTUAL PROPERTY ASSIGNMENT (this "Assignment"), dated as of November 7, 2013, is made and entered into by and among Windhover Information Inc., a Connecticut corporation ("Windhover"), F-D-C Reports Inc., a Delaware corporation ("FDC"), Elsevier Inc., a Delaware corporation ("Elsevier," and together with Windhover and FDC, each individually an "Assignor" and collectively the "Assignors"), and Informa Business Information, Inc., a Massachusetts corporation (the "Assignee"). Capitalized terms used in this Assignment without definition have the respective meanings given to them in the Purchase Agreement (as defined below).

RECITALS

WHEREAS, Assignors are engaged in the business of publishing and providing business intelligence on policy, regulatory, business and reimbursement issues to professionals in the biopharmaceutical and medical device industries through certain publications, conferences and websites, products, and a certain database (the "Business");

WHEREAS, Assignors and Assignee are parties to a certain Asset Purchase Agreement, dated as of the date hereof (the "Purchase Agreement"), pursuant to which Assignors have sold to Assignee, among other things, certain intellectual property owned by Assignors which is used in the conduct of the Business as conducted as of the date hereof (the "Sellers Intellectual Property"); and

WHEREAS, Assignors desire to sell, transfer and assign to Assignee all right, title and interest of Assignors in and to the Sellers Intellectual Property, together with the goodwill associated therewith, and Assignee desires to acquire the Sellers Intellectual Property from Assignors;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged and intending to be legally bound, the Assignors acknowledge as follows:

Assignment and Transfer. Assignors hereby assign, transfer, convey and deliver to Assignee all of Assignors' right, title and interest in and to:

(A) those certain trademarks and service marks, and all registrations thereof and applications for registration therefor, which are identified in Exhibit A hereto, together with the goodwill of the Business associated therewith (the "Trademarks");

(B) those domain names identified in Exhibit B hereto (the "Domain Names");

(C) those copyright registrations identified in Exhibit C hereto (the "Copyrights");


Purchase Agreement Governs. In the event of any inconsistencies or ambiguities between this Assignment and the Purchase Agreement, the terms of the Purchase Agreement shall govern.

Counterparts. This Assignment may be executed in two or more counterparts, each of which shall constitute an original, but all of which taken together shall constitute one and the same instrument.


