The owner of this registration requests that the record be corrected to show that its correct entity name is "The Armor All/STP Products Company," not "The Amor All/STP Products Corporation."

Registrant is merely correcting errors in the recordation cover sheet for the merger recorded at Reel 3078 / Frame 0510.
