**(a Delaware corporation)**

Pursuant to Title 8, Section 252 of the Delaware General Corporation Law, the undersigned corporation executed the following Certificate of Merger:

**FIRST:** The name of each constituent corporation is Polyform Products Company, an Illinois corporation, and Polyform Products Company, Inc., a Delaware corporation.

**SECOND:** The Agreement and Plan of Merger has been approved, adopted, certified, executed and acknowledged by each of the constituent corporations.

**THIRD:** The name of the surviving corporation is Polyform Products Company, Inc., a Delaware corporation.

**FOURTH:** The Certificate of Incorporation of Polyform Products Company, Inc. as in effect immediately prior to the merger shall become the Certificate of Incorporation of the surviving corporation. The Bylaws of Polyform Products Company, Inc. as in effect immediately prior to the merger shall become the Bylaws of the surviving corporation.

**FIFTH:** The authorized capital stock of the constituent corporation which is not a corporation of the State of Delaware is 1,000,000 shares of Class A common voting stock, no par value, and 10,000,000 shares of Class B common nonvoting stock, no par value.

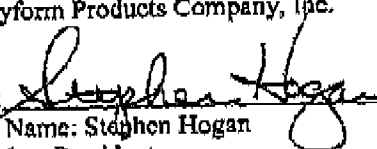
**SIXTH:** The merger is to become effective upon the filing of this Certificate of Merger with the Secretary of State of Delaware.
