GRANT OF SECURITY INTEREST
PATENTS AND TRADEMARKS

FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, FORESEE RESULTS, INC., a Delaware corporation (the “Grantor”) on this 20th day of December, 2013, pledges and grants to SUNTRUST BANK, as Collateral Agent (together with its successors and assigns, the “Grantee”), a security interest in (i) all of the Grantor’s right, title and interest in and to the Trademarks and Trademark Licenses (the “Trademark Collateral”) set forth on Schedule A attached hereto and all reissues, reexaminations, divisions, extensions or renewals thereof; (ii) all of the Grantor’s right, title and interest in and to the Patents and Patent Licenses (the “Patent Collateral”) set forth on Schedule B attached hereto and all reissues, reexaminations, divisions, continuations, continuations-in-part and extensions thereof, in each case together with (iii) all Proceeds (as such term is defined in the Guarantee and Collateral Agreement referred to below) of the Trademark Collateral and Patent Collateral, (iv) the goodwill of the businesses with which the Trademark Collateral and Patent Collateral are associated, and (v) all causes of action arising prior to or after the date hereof for infringement of any of the Trademark Collateral and Patent Collateral or unfair competition or breach regarding the same.


