GRANT OF SECURITY INTEREST  
PATENTS AND TRADEMARKS

FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, ANSWERS CORPORATION, a Delaware corporation (the “Grantor”) on this 20<sup>th</sup> day of December, 2013, pledges and grants to SUNTRUST BANK, as Collateral Agent (together with its successors and assigns, the “Grantee”), a security interest in (i) all of the Grantor’s right, title and interest in and to the Trademarks and Trademark Licenses (the “Trademark Collateral”) set forth on Schedule A attached hereto and all reissues, reexaminations, divisions, extensions or renewals thereof; (ii) all of the Grantor’s right, title and interest in and to the Patents and Patent Licenses (the “Patent Collateral”) set forth on Schedule B attached hereto and all reissues, reexaminations, divisions, continuations, continuations-in-part and extensions thereof, in each case together with (iii) all Proceeds (as such term is defined in the Guarantee and Collateral Agreement referred to below) of the Trademark Collateral and Patent Collateral, (iv) the goodwill of the businesses with which the Trademark Collateral and Patent Collateral are associated, and (v) all causes of action arising prior to or after the date hereof for infringement of any of the Trademark Collateral and Patent Collateral or unfair competition or breach regarding the same.

THIS GRANT OF SECURITY INTEREST (this “Grant”), is made to secure the satisfactory performance and payment of all the “Obligations” of the Grantor, as such term is defined in that certain Second Lien Guarantee and Collateral Agreement among Grantor, the other grantors from time to time party thereto and the Grantee, dated as of December 20, 2013 (as the same may be amended, restated, supplemented or otherwise modified from time to time, the “Guarantee and Collateral Agreement”). All initially capitalized terms used but not otherwise defined herein have the meanings given to them in the Guarantee and Collateral Agreement.

This Grant has been granted in conjunction with the security interest granted to the Grantee under the Guarantee and Collateral Agreement. The rights and remedies of the Grantee with respect to the security interest granted herein are without prejudice to, and are in addition to those set forth in the Guarantee and Collateral Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Grant are deemed to conflict with the Guarantee and Collateral Agreement, the provisions of the Guarantee and Collateral Agreement shall govern. This Grant may be executed in counterparts.
