TRADEMARK ASSIGNMENT

This **TRADEMARK ASSIGNMENT** (this "Assignment") dated as of November 14, 2013 (the "Effective Date") is by and between **TCI Holdings, LLC**, a Florida limited liability company, having an address at 8180 N.W. 36th Street, #105, Miami, Florida 33166 ("Assignor"), and **2395485 Ontario Inc.**, a Canadian corporation, having a place of business at 333 Foster Crescent, Suite 1, Mississauga, Ontario, L5R 4E5, Canada ("Assignee").

WHEREAS, Assignor is the owner of the world-wide rights in the common law trademarks, trademark applications and trademark registrations listed on Schedule "A" attached hereto (collectively herein the "Trademarks"), and

WHEREAS, Assignee desires to acquire the entire right, title and interest in and to Trademarks from Assignor pursuant to this Assignment.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the parties hereby agree as follows:

1. Assignment. Assignor hereby assigns unto the Assignee, all of its right, title, and interest in and to the Trademarks, free and clear of all liens and encumbrances, together with the on-going business to which the Trademarks pertain, all of the goodwill associated with and symbolized by such Trademarks, the registrations thereof and therefor, and any rights of the Assignor to sue any third parties for any past infringement, or other claims, of or to the Trademarks, for the use and benefit of the Assignee and to prosecute such registrations in the United States Patent and Trademark Office and any other Foreign Trademark Office.

2. Trademark Assignment Agreement. Nothing contained herein is intended to modify, amend or alter in any respect the rights and obligations of the parties under that certain Trademark Assignment Agreement between Assignor and Assignee dated as of the date set forth above, which will remain in full force and effect notwithstanding the execution and delivery of this Assignment.

After the execution of this Assignment, at the request of the Assignee and at the Assignee's expense, but without additional consideration to the Assignor, the Assignor will execute and deliver to the Assignee from time to time such further instruments of conveyance, transfer, and assignment and other documents, and will take such other actions, as the Assignee may reasonably require to convey and deliver more effectively to the Assignee the Trademarks, to perfect the Assignee's title thereto, and otherwise to accomplish the orderly transfer to the Assignee of the Trademarks and to give full effect to this Assignment.


This Assignment is binding on the Assignor and its successors and assigns, and inures to the benefit of the Assignee and its successors and assigns.


