## TRADEMARK ASSIGNMENT

WHEREAS, David S. Evey ("ASSIGNOR"), being the lawful owner of the trademark NURVARA in connection with the manufacturing and selling of candles (the "Mark"), together with the federal trademark registration therefore (Reg. No. 3396552) (the "Registration") and the goodwill of the business in connection with which NUVARA has been used (the "Goodwill"); and

WHEREAS, Zensual, Inc., a California corporation with its principal place of business at 9190 W. Olympic Blvd., Suite 421, Beverly Hills, CA ("ASSIGNEE"), desires to acquire the Mark and the Goodwill;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, ASSIGNOR has agreed to sell, assign, transfer and set over, and by these presents does sell, assign, transfer and set over unto ASSIGNEE and its successors and assigns ASSIGNOR'S entire rights, title, free and clear of all liens, and interest in and to the Mark, the Registration and the Goodwill to be held and enjoyed by ASSIGNEE for its own use and benefit and for the use of its affiliates, successors, assigns, and licensees to be used as fully and entirely as such rights would have been held and enjoyed by ASSIGNOR had this Assignment not been made, including the right to sue for past, present, and future infringement.

ASSIGNOR covenants that ASSIGNOR is the owner of the Mark, the Registration, and the Goodwill, that ASSIGNOR has secured the release of all liens against the Mark, the Registration and the Goodwill, and that ASSIGNOR has full power to make this Assignment and that ASSIGNOR agrees to execute such further assignments and related documents with respect to the Mark, the Registration and the Goodwill as ASSIGNEE shall reasonably request.
