**TERMINATION AND RELEASE OF  
SECURITY AGREEMENT**

THIS TERMINATION AND RELEASE OF SECURITY AGREEMENT (the "Termination"), dated as of December 20, 2013, is executed by Silicon Valley Bank (the "Secured Party") in favor of ForeSee Results, Inc., a Delaware corporation (together with its successors and assigns, the "Grantor"). Capitalized terms used herein, not otherwise defined, shall have the meaning assigned in the Security Agreement (defined below).

Recitals

A. Reference is hereby made to that certain Intellectual Property Security Agreement, dated as of October 26, 2008 (as amended, restated, modified or supplemented and in effect from time to time, including by that certain First Amendment to Intellectual Property Security Agreement, dated as of December 8, 2009, by and between the Secured Party and the Grantor, the "Security Agreement"), executed by Grantor in favor of Secured Party wherein Grantor granted to Secured Party a security interest in the Intellectual Property Collateral.

B. The Security Agreement was recorded with the Trademark Division of the United States Patent and Trademark Office on January 5, 2010, at Reel/Frame 4125/0064 to evidence the security interest granted under the Security Agreement.

C. Grantor has satisfied in full the obligations under and secured by the Security Agreement and Secured Party has agreed to terminate and release its security interest in the Copyrights, Patents and Trademarks (as defined in the Security Agreement) as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Secured Party expressly terminates and releases its right, title and interest in, to and under Grantor's registered and unregistered intellectual property collateral (all of which shall collectively be called the "Intellectual Property Collateral"), including, without limitation, the following:

all intellectual and similar property of every kind and nature now owned or hereafter acquired by Grantor, including those set forth on Schedule 1, inventions, designs, patents (whether registered or unregistered), copyrights (whether registered or unregistered), trademarks (whether registered or unregistered), trade secrets, domain names, confidential or proprietary technical and business information, know-how, methods, processes, drawings, specifications or other data or information and all memoranda, notes and records with respect to any research and development, software and databases and all embodiments or fixations thereof whether in tangible or intangible form or contained on magnetic media readable by machine together with all such magnetic media and related documentation, registrations and franchises, and all additions, improvements and accessions to, and books and records describing or used in connection with, any of the foregoing.
