**ASSIGNMENT OF TRADEMARK, TRADEMARK APPLICATION,
AND ACCOMPANYING GOODWILL**

This Assignment of Trademark, Trademark Application, and Accompanying Goodwill (this "Assignment") is entered into as of December 18, 2013 by and between Crowned Heads, LLC, a limited liability company organized and existing under the laws of Tennessee, located at 6172 Cockrill Bend Circle, Nashville, Tennessee 37209 (the "Assignor"), and National Grange of the Order of Patrons of Husbandry, a non-profit corporation organized and existing under the laws of the District of Columbia, located at 1616 H Street NW, Washington, DC 20006 (the "Assignee"), in accordance with the terms of that certain Settlement Agreement, dated as of June 3, 2013, by and between Assignor and Assignee (the "Settlement Agreement"). 
For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby sell, assign, transfer and set over to Assignee, all of Assignor's United States' rights, title and interest in and to the trademark identified in Schedule A attached hereto (the "Mark"), any registrations therefore throughout the United States and any renewals or extensions of such registrations, together with the goodwill of the business in connection with which the Mark is used and which is symbolized by the Mark and the resulting right to recover damages and profits for past, present or future infringements or unauthorized uses thereof, with the right to sue for and collect the same for its own use and enjoyment, as fully and entirely as the same would have been held and enjoyed by Assignor, if this assignment and sale had not been made.

Notwithstanding anything to the contrary contained herein, the terms of this Assignment are subject to the terms, provisions, conditions and limitations set forth in the Settlement Agreement and License Agreement between the parties (collectively, the "Agreements"), and this Assignment is not intended to alter the rights or obligations of the parties to the Agreements. In the event of any inconsistencies between the terms of this Assignment and the terms of the Agreements, and with respect to matters addressed in the Agreements but not addressed herein, the parties hereto agree that the terms of the Agreements shall control.

This Assignment may be executed in any number of counterparts, each of which shall be deemed an original, but all of which together shall constitute only one instrument.


