SECOND LIEN INTELLECTUAL PROPERTY SECURITY AGREEMENT

This Second Lien Intellectual Property Security Agreement (as amended, supplemented or otherwise modified from time to time, this "Second Lien IP Security Agreement") is made and effective as of December 23, 2013, by and among RUG DOCTOR, LLC (f/k/a Rug Doctor, Inc.), a Delaware limited liability company ("Borrower") and RD HOLDCO INC., a Delaware corporation ("Holdco", together with Borrower, each a "Grantor" and collectively, "Grantors") in favor of Solar Capital Ltd., a Maryland corporation, and American Capital, Ltd., a Delaware corporation, in their capacities as administrative and collateral agents for the Lenders (defined below) and each other Secured Party (as such term is defined in the Second Lien Credit Agreement) (in such capacity, the "Agents"). Capitalized terms used in this Second Lien IP Security Agreement and not otherwise defined shall have the respective meanings ascribed to such terms in the Second Lien Credit Agreement.

RECITALS

WHEREAS, pursuant to that certain Second Lien Credit Agreement, dated as of the date hereof, by and among each Grantor, Agents and Lenders from time to time party thereto (as amended, supplemented or otherwise modified from time to time, the "Second Lien Credit Agreement"), the Lenders have agreed, among other things, subject to the terms and conditions set forth therein, to make Loans to the Borrower (collectively, the "Loans");

WHEREAS, each Grantor will derive substantial direct and indirect benefit from the Loans and other financial accommodations provided by the Lenders under the Second Lien Credit Agreement; and

WHEREAS, it is a condition precedent to the obligation of the Agents and the Lenders to execute and perform under the Second Lien Credit Agreement that each Grantor shall have executed and delivered this Second Lien IP Security Agreement to the Agents for the ratable benefit of the Secured Parties;

NOW, THEREFORE, in consideration of the willingness of the Agents and the Lenders to enter into the Second Lien Credit Agreement and to agree, subject to the terms and conditions set forth therein, to make the Loans pursuant thereto, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, it is hereby agreed as follows:

AGREEMENT

1. Grant of Security Interest. To secure the Grantors' prompt, punctual and faithful payment of the Loans and the performance of all and each of the Grantors' Obligations under the Second Lien Credit Agreement, each Grantor hereby grants to the Agents, for the ratable benefit of the Secured Parties, a continuing security interest in all of the right, title and interest of such Grantor in and to any and all of the following collateral, whether now owned or hereafter acquired, but excluding any intellectual property rights licensed in which such Grantor is prohibited from granting a security interest by contract, statute, or otherwise (the "IP

Collateral):

(a) The U.S. and foreign patents and patent applications set forth on Schedule A attached hereto (collectively, the "Patents");

(b) The U.S., state and foreign trademark and service mark registrations, trademark and service mark applications set forth on Schedule B attached hereto and all goodwill associated with the foregoing (provided that no security interest shall be granted in United States intent-to-use trademark applications to the extent that the grant of a security interest therein would impair the validity or enforceability of such intent-to-use trademark applications under applicable federal law) (collectively, the "Trademarks");

(c) The copyrights set forth on Schedule C attached hereto (collectively, the "Copyrights");

(d) The domain names and registrations set forth on Schedule D attached hereto and all goodwill associated with the foregoing (collectively, the "Domain Names");

(e) Any and all claims and causes of action for past, present or future infringement of any of the IP Collateral, with the right, but not the obligation, to sue for and collect damages for infringement of the IP Collateral;

(f) Any and all licenses or rights granted under any of the IP Collateral (excluding those licenses in which a Grantor is prohibited from granting a security interest by contract, statute or otherwise), and all license fees and royalties arising from such licenses or rights;

(g) Any and all divisions, continuations, amendments, renewals, extensions, reissuances and replacements of any of the items listed in clauses (a) through (e) of this paragraph; and

(h) Any and all products and proceeds of any of the foregoing.

2. Requested Recordation. Each Grantor authorizes and requests that the Commissioner of Patents and Trademarks and the Register of Copyrights (and any state, foreign or other authority to which this Second Lien IP Security Agreement is submitted) file and record this Second Lien IP Security Agreement (and any corresponding or separate forms of such jurisdiction) in order to publicly reflect the interests of the Agents and the Secured Parties in the IP Collateral.

3. Assignment. Upon the request of the Agents after the occurrence and during the continuance of an Event of Default, each Grantor shall execute and deliver to the Agents an absolute assignment transferring its entire right, title, and interest in and to the IP Collateral to the Agents, for the ratable benefit of the Secured Parties.

4. Power of Attorney. Each Grantor hereby irrevocably grants to the Agents, for the ratable benefit of the Secured Parties, a power of attorney, to act as such Grantor's attorney-in-

fact, with full authority in the name, place and stead of such Grantor, from time to time in the Agents' discretion, to take any action and to execute any instrument that the Agents may reasonably deem necessary or advisable to accomplish the purposes of this Second Lien IP Security Agreement. This authority includes, without limitation, the following:

(a) To modify or amend (in the sole discretion of the Agents and the Secured Parties and without first obtaining such Grantor's approval thereof or signature thereto) Schedule A, Schedule B, Schedule C and/or Schedule D hereof, as appropriate, to include references to any registered intellectual property (or application or license therefor) acquired by such Grantor after the execution hereof or to delete any reference to any IP Collateral in which such Grantor no longer has or claims any right, title or interest;

(b) To execute, file and pursue (in the sole discretion of the Agents and the Secured Parties and without first obtaining such Grantor's approval thereof or signature thereto, unless otherwise prohibited by applicable law) any application, form or other document in order to perfect, maintain, continue or otherwise protect the Agents' interest or such Grantor's rights in the IP Collateral, including, without limitation, executing and filing (i) any financing statement, any continuation statement or any amendment thereto, and (ii) any document in any proceeding before the United States Patent and Trademark Office, United States Copyright Office or the relevant office of any state or foreign jurisdiction (including, without limitation, the filing of applications for renewal, affidavits of use, affidavits of incontestability and opposition, interference and cancellation proceedings) and to pay any fees and taxes in connection therewith or otherwise;

(c) To execute any document required to acknowledge, register or perfect the interest of the Agents and the Secured Parties in any part of the IP Collateral without the signature of such Grantor unless prohibited by applicable law; and

(d) Upon the occurrence and during the continuation of an Event of Default, to (i) endorse the respective Grantor's name on all applications, documents, papers and instruments necessary or desirable for the Agents in the use of the IP Collateral, (ii) take any other actions with respect to the IP Collateral as the Agents deem in their discretion to be in the best interest of the Agents, (iii) grant or issue any exclusive or non-exclusive license (except where prohibited by statute, contract or otherwise) under the IP Collateral to anyone or (iv) assign, pledge, convey or otherwise transfer title in or dispose of the IP Collateral to anyone.

The foregoing power of attorney is coupled with an interest and is irrevocable until the Grantor's obligations under the Second Lien Credit Agreement and the other Transaction Documents (collectively, the "Obligations") secured hereby have been unconditionally and indefeasibly paid or performed in full and the Second Lien Credit Agreement has been terminated (other than indemnity obligations under the Transaction Documents that are not then due and payable or for which events or claims that would give rise thereto are not then pending).

5. Release. Unless otherwise agreed in writing by the parties, the security interests

granted herein will terminate (and all rights to the IP Collateral will revert to each of the Grantors) upon satisfaction of the following conditions: (a) payment and performance in full of all the Obligations (other than indemnity obligations under the Transaction Documents that are not then due and payable or for which events or claims that would give rise thereto are not then pending) secured hereby (unconditionally and indefeasibly) and (b) the termination of the Second Lien Credit Agreement (except for any obligations designated thereunder as continuing on an unsecured basis). Upon any such termination, the Agents (at the Grantors' request and sole expense) will promptly execute and deliver to the Grantors (with such customary representations and warranties from a secured lender releasing its lien as the Grantors may reasonably request) such documents as the Grantors may reasonably request and as are provided to the Agents to evidence such termination.

6. Newly Registered Patents and Trademarks. Each Grantor hereby agrees to provide the Agents, for the ratable benefit of the Secured Parties, every quarter, a schedule of newly registered Patents, Trademarks and Copyrights (if any).

7. Miscellaneous.

(a) This Second Lien IP Security Agreement has been entered into in conjunction with the provisions of and the security interest granted to the Agents, for the ratable benefit of the Secured Parties, under the Second Lien Credit Agreement. The rights and remedies of the Grantors and the Agents with respect to the security interests granted herein are in addition and without prejudice to those set forth in the Second Lien Credit Agreement, all terms and provisions of which are hereby incorporated herein by reference. In the event that any provisions of this Second Lien IP Security Agreement are deemed to conflict with the Second Lien Credit Agreement or the other Transaction Documents, the provisions of the Second Lien Credit Agreement or the other Transaction Documents shall govern.

(b) This Second Lien IP Security Agreement may be executed in any number of counterparts with the same effect as if all the signatures on such counterparts appeared on one document. Each such counterpart will be deemed to be an original, but all counterparts together will constitute one and the same instrument.

(c) Notwithstanding any provision contained herein, (i) this Second Lien IP Security Agreement, the Liens created hereby and the rights, remedies, duties and obligations provided for herein are subject to the Intercreditor Agreement and (ii) in the event of a conflict, the provisions of the Intercreditor Agreement shall control. Without limiting the generality of the foregoing, any requirement to deliver possessory Collateral to the Agent shall be deemed satisfied if such possessory Collateral is delivered to the Control Agent, as bailee for perfection for the Agent, in accordance with the terms of the Intercreditor Agreement.


