

ABB Inc., a corporation incorporated on the 10th day of November, 1980, pursuant to the provisions of the General Corporation Law of the State of Delaware,

DOES HEREBY CERTIFY:

FIRST: That this corporation owns 100% of the capital stock of Jokab Safety North America Inc., a corporation incorporated on the 30th day of October, 2002 A.D., pursuant to the provisions of the Corporation Law of the State of Michigan and that this corporation, by a resolution of its Board of Directors duly adopted by Unanimous Written Consent as of the 15th day of December, 2010 A.D., determined to and did merge into itself said Jokab Safety North America, Inc., which resolution is in the following words, to wit:

NOW, THEREFORE, BE IT

RESOLVED, that this corporation merge into itself said Jokab Safety North America Inc. and assumes all of its obligations, and

FURTHER RESOLVED, that an authorized officer of this corporation be and he or she is hereby directed to make and execute a certificate of ownership setting forth a copy of the resolution to merge said Jokab Safety North America Inc. and assume its liabilities and obligations, and the date of adoption thereof, and to file the same in the office of the Secretary of State of Delaware, and a certified copy thereof in the office of the Recorder of Deeds of New Castle County; and

FURTHER RESOLVED, that the officers of this corporation be and they hereby are authorized and directed to do all acts and things whatsoever, whether within or without the State of Delaware; which may be in any way necessary or proper to effect said merger.

FURTHER RESOLVED, that the merger shall become effective on filing of the certificate of ownership;

SECOND: That anything herein or elsewhere to the contrary notwithstanding, this merger may be amended or terminated and abandoned by the Board of Directors of ABB Inc. at any time prior to the time that this merger filed with the Secretary of State becomes effective.
