TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (the "Assignment") dated as of September 27, 2013, by and among KDGA, LLC, an Idaho limited liability company ("Assignor"), H Corp, an Idaho corporation and Manager of Assignor, Kevin Hulsey, President of H Corp ("Hulsey"), and approved by RehabAuthority, LLC an Idaho limited liability company ("RehabAuthority"), for which H Corp is Manager, in favor of Idaho Rehabilitation Partners, LLC, an Idaho limited liability company ("Assignee").

RECITALS

WHEREAS, Assignor owns the trademark registered with the United States Patent and Trademark Office (USPTO) for the mark "RehabAuthority," with the Registration No. 3158424 (the "Trademark").

WHEREAS, Assignor is owned by a Members constituting a Majority of Membership Interest, which also own Membership Interest in RehabAuthority;

WHEREAS, RehabAuthority is involved in a transaction with Assignee which will result in RehabAuthority owning Membership Interest in Assignee under the Membership Interest Purchase Agreement (the "MIPA");

WHEREAS, a condition of the MIPA includes the transfer and assignment of the Trademark by Assignor to Assignee; and

WHEREAS, pursuant to the MIPA, the Trademark is to be sold, transferred and assigned to Assignee with all of Assignor's right, title and interest in, to, and under the Trademark (the "Assignment of Trademark") prior to closing of the MIPA.

NOW, THEREFORE, Assignor and Assignee hereby confirm the Assignment of Trademark for purposes of filing the same with the USPTO and agree as follows.

ASSIGNMENT

1. For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby transfers, assigns, and otherwise conveys to Assignee, all of Assignor's right, title and interest in, to, and under the following:

- a. the Trademark "RehabAuthority" with the USPTO Registration No. 3158424;
- b. the goodwill associated with the Trademark; and


c. all rights to proceeds of the foregoing, including, without limitation, any claim by Assignor against third parties for past, present, or future infringement of the Trademark.

2. Assignor hereby authorizes and requests the USPTO to issue the certificate of registration in respect of the Trademark to Assignee for its sole use, and for the use of its legal representatives and assigns, to the full end of the term for which such registration may be granted, as fully and entirely as the same would have been held by Assignor had this assignment not been made.

Assignor has caused this Trademark Assignment to be duly executed and authorized as of the date first written above.


