And for the consideration aforesaid, Assignor hereby covenants and agrees to and with the said Assignee, its successors and assigns, that at the time of the execution and delivery of these presents, Assignor is the sole and lawful owner of the entire right, title, and interest in and to the Trademarks, and that Trademarks has good right and lawful authority to sell, convey, assign, and transfer the same in the manner herein set forth.


And for the consideration aforesaid, Assignor hereby covenants and agrees to and with the said Assignee, its successors and assigns, that Assignor will, whenever its counselor or the counsel of its successors and assigns, learned in the law, shall advise as lawful, sign all papers and drawings, take all rightful oaths, and do all acts necessary, desirable, or required to be done for the procurement or transfer of ownership of the Trademarks to Assignee.

Said sale, conveyance, assignment, and transfer includes, without limitation, the privileges and the rights to enforce, to assert, and to sue for past, present, and future infringement of the Trademarks, and the rights to recover and to collect for past, present, and future damages related to the Trademarks.
