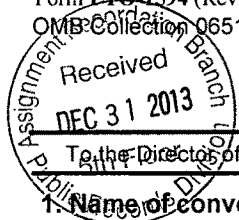



THEREFORE, Assignor shall cease using the BOW COMMANDER trademark by March 1, 2014.


