**RELEASE OF SECURITY INTEREST IN
INTELLECTUAL PROPERTY**

This RELEASE, dated as of December 16, 2013, is made by CALIFORNIA BANK & TRUST (“Bank”).

W I T N E S S E T H

WHEREAS, Sigue Corporation (the “Grantor”), and the Bank were parties to that certain Loan and Security Agreement dated as of November 16, 2001, and certain other instruments, documents and agreements related thereto (collectively, the “Loan Documents”);

WHEREAS, pursuant to the Intellectual Property Security Agreement dated November 16, 2001 (the “Agreement”) and recorded with the U.S. Patent and Trademark Office on December 14, 2001 at Reel/Frame No. 2409/0424, the Grantor granted to the Bank a first priority security interest in all of its right, title, and interest in and to the Collateral (as defined in the Agreement); and

WHEREAS, the Grantor has requested that the Bank terminate and release its security interest in all of its right, title and interest in and to its Collateral, including those trademark registrations set forth on Schedule I.

NOW, THEREFORE, the Bank hereby DISCHARGES, TERMINATES and RELEASES, without recourse its security interest on all of its right, title and interest in and to the Collateral, including the trademark registrations set forth on Schedule I, attached hereto and incorporated herein by reference, and agrees that all the security interest in the Collateral are hereby discharged, terminated and released and hereby transfers and assigns to the Grantor any and all right, title and interest that the Bank may have obtained in, to and under the Collateral under the Agreement and the Loan Documents.

The Bank agrees to provide the Grantor with any information and additional authorization reasonably necessary to effect the release of the Bank’s security interest in the Collateral.
