Release of Security Interest in Trademark Rights

THIS RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS (this “**Release**”) is entered into as of January 2, 2014 by and between LPS IP Holding Company, LLC, a Delaware limited liability company (the “**Assignor**”) and JPMorgan Chase Bank, N.A., as collateral agent (the “**Agent**” or the “**Assignee**”) for the lenders party to that Amended and Restated Credit Agreement, dated as of August 18, 2011 (as further amended, restated, amended and restated, supplemented or otherwise modified from time to time), among Lender Processing Services, Inc., the lenders party thereto and the Agent, as administrative agent, Swing Line Lender and L/C Issuer.

WHEREAS, pursuant to the terms and conditions of that certain Security Agreement dated as of July 2, 2008, as amended and restated by that certain Amended and Restated Security Agreement dated as of August 18, 2011 (the “**Security Agreement**”; all capitalized terms used but not defined herein shall have the respective meanings ascribed thereto in the Security Agreement), the Assignor (or the relevant predecessor in interest, as applicable) granted to the Assignee a continuing security interest in and lien on all of its right, title and interest in and to the Trademark Collateral (as defined in each of the Trademark Security Agreements (as defined below));

WHEREAS, reference is made to those Trademark Security Agreements dated as of July 2, 2008, March 26, 2009, February 23, 2010, April 26, 2010, July 28, 2010, November 26, 2010, March 31, 2011, August 18, 2011, November 1, 2011, February 18, 2012, May 18, 2012, August 1, 2012, October 19, 2012, February 28, 2013 and June 29, 2013 (as amended, restated, amended and restated, supplemented or otherwise modified immediately prior to the date hereof, the “**Trademark Security Agreements**”), which granted to the Assignee for the benefit of the Secured Parties a continuing security interest in all of the right, title and interest of the Assignor (or the relevant predecessor in interest, as applicable) in and to the Trademark Collateral, including, without limitation, each Trademark registration and application referred to in Schedule A hereto;

WHEREAS, such Trademark Security Agreements were recorded with the United States Patent and Trademark Office (the “**USPTO**”) on reel 3838 frame 0348; reel 3837 frame 0684; reel 3968 frame 0844; reel 3837 frame 0652; reel 3837 frame 0637; reel 4305 frame 0722; reel 4305 frame 0854; reel 4258 frame 0827; reel 4429 frame 0099; reel 4544 frame 0510; reel 4607 frame 0161; reel 4861 frame 0494 and reel 4839 frame 0750;

WHEREAS, the Agent has agreed to terminate and release its security interest in and lien on the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

SECTION 1. *Release of Security Interest in Trademark Collateral.*

- (a) The Agent hereby terminates the Trademark Security Agreements and hereby cancels, re-pledges, reassigns and releases any and all security interests it has against the Trademark Collateral.
- (b) If and to the extent the Agent has acquired any right, title or interest in, to or under any of the Trademark Collateral, the Agent hereby assigns, transfers, conveys and delivers such right, title or interest to the Assignor.
- (c) The Agent hereby agrees, at the expense of the Assignor, to execute and deliver to the Assignor such additional documents, instruments and certificates, and take such other actions, as the Assignor shall reasonably request to evidence the termination of the Agent's lien on, and the release of, the Trademark Collateral.

SECTION 2. *Recordation of Release.* The Agent hereby authorizes and requests that the Commissioner for Trademarks in the USPTO, and any other necessary United States government officer, record this Release; it being understood that such recordation shall be at the Assignor's sole expense.


